Program Description

We are proud to offer an exceptional 53-week hospital-based optometric residency at the University of Chicago, designed to elevate clinical expertise in ocular disease diagnosis and management. This dynamic program provides a rare opportunity to train in a collaborative optometry and ophthalmology environment, where teamwork and interdisciplinary care are prioritized.

Residents will deepen their understanding of systems-based eye care while mastering the art of communication and co-management across a variety of medical specialties. Clinical experience is customizable and spans both adult and pediatric ocular disease, urgent care, as well as immersive rotations with esteemed ophthalmology subspecialists.

Beyond hands-on training, education is enriched with engaging grand rounds, interactive lectures, and journal clubs—ensuring comprehensive professional development.

Residents completing the program will gain the necessary experience to:

- Pursue professional & multi-disciplinary opportunities requiring a high-level of expertise in medical eye care.
- Serve as educators and researchers in academic settings.
- Serve the profession of optometry as experts and leaders in the area of ocular disease management.

Program Design: Resident Schedule, Rotations, and Clinical Assignments

Weekly Commitment: 42 hours (average)

Rotations:

- **Adult Ocular Disease:** Comprehensive experience in diagnosis and management (28 hours/week)
- **Consult/Urgent Care:** Acute care and patient consultation (4 hours/week)
- **Ophthalmology Sub-Specialty:** Exposure to diverse disciplines, rotating bimonthly (4 hours/week)
- **Optometry Seminar:** Clinical reviews and case discussions (1 hour/bi-weekly)
- **Ophthalmology Grand Rounds:** Multidisciplinary teaching sessions (1 hour/week)
- **Personal Development:** Dedicated time for professional growth (4 hours/week)

Ophthalmology Sub-Specialty Rotations

- Residents can select from Cornea, Glaucoma, Neuro-Ophthalmology, Oculoplastics, Pediatrics, and Retina
- Each rotation lasts two months and is customizable to resident interests
- Instruction provided by University of Chicago ophthalmology specialists

Clinical Assignments & Coverage

- **Schedule:** Monday to Friday; no weekend or mandatory on-call duties
- **Clinic Sessions:** Three patient care sessions Monday through Thursday (Friday has two sessions, no evening clinic)
- **Consults:** Provide urgent outpatient eye care every week during normal business hours (before 4 PM); optional inpatient rounds with ophthalmology residents
- **Evening Shifts:** Minimum of three evening sessions per week, with scheduling flexibility based on educational opportunities
- **Emergent Care Option:** Residents may opt to participate in buddy call with ophthalmology residents during after-hours or weekends if they are interested in emergency care

Benefits

Benefits include eligibility to participate in medical and dental insurance programs, professional liability insurance, vacation, paid sick leave, and a travel allowance to attend optometric conferences.

Eligibility

Entry into the Optometry Residency Program at the University of Chicago requires completion of optometry school accredited by the Accreditation Council on Optometric Education (ACOE). Applicants must prove successful passage of the National Board of Examiners in Optometry® (NBEO) Parts I, II, and III, as well as Treatment and Management of Ocular Disease (TMOD). Applicants must be citizens of the United States of America and be eligible for licensure in the State of Illinois.

Selection

All applications are handled online via the ORMatch System at National Matching Services, Inc. Curriculum vitae, GPA, NBEO scores, three letters of recommendation, and an interview are used for the selection process.

Criteria for Completion

- Successful completion of all clinical assignments
- Attendance and participation at weekly education conferences
- A written paper of publishable quality or case report. The case report can be part of an application for fellowship in the American Academy of Optometry.
